Psalm 33:4-6: "⁴ For the word of the LORD is upright, and all his work is done in faithfulness. ⁵ He loves righteousness and justice; the earth is full of the steadfast love of the LORD. ⁶ By the word of the LORD the heavens were made, and by the breath of his mouth all their host."

God's Justice (Part II)

Last month, we discussed how a key dynamic that makes the biblical understanding of justice significantly *different* than our modern understanding. That dynamic was the all-encompassing nature of God's judgments. As twenty-first Century Americans, we tend to think of justice as measurable outcomes within a political setting. In these cases, if God is brought into the conversation at all, it is typically only for manipulative purposes, to show that one side has divine endorsement for their view of what is fair while the other side does not.

Scripture, however, shows God's judgments as connected to His authority as Creator and as the one from whom true knowledge and action proceeds. Thus, God's judgments uphold the universe but also tell us the truth about who we are: the destruction of sin and God's plan in Christ to deal with that sin. Justice then has less to do with measurable outcomes and more to do with repentance and acknowledging God's authority. When we think God has not given us what we deserve, we are questioning His wisdom and justice by insinuating there is something we deserve beyond or above His grace to us in Christ. Yet, in Christ, we see God's justice on full display. Through the law God has judged us all sinners (Romans 11:32; Gal. 3:22) and condemned us, but through the blood of Christ, He has declared us righteous and holy. Thus, God's justice resides in the judgments rendered through Christ, judgments that apply to both our sin and our salvation. This kind of justice talk, however, is glaringly absent from modern discussions of justice. Why? Because modern notions of justice are just that, modern, and while this does not make them necessarily harmful, it does make them fundamentally unbiblical.

Another example of this difference is whether we see ourselves as governed by laws or by a person. As modern people, we have a strong tendency to see ourselves as governed by laws, so justice is achieved by just laws and institutions, and injustice is eliminated by dismantling or changing laws and institutions. This view is substantially different from a biblical view. In the ancient world, you were foremost ruled by people (kings, rulers, princes, elders) and not by laws. Therefore, the laws, no matter how just, were only as good as the leader charged with their enforcement. Ideally, a good leader had the leisure and time to make good judgments, could make his judgments respected within the community, and through his acknowledged leadership superiority within the community, would be expected to bring his deeper reflection and experience to bear on judgements.

This focus on a person instead of set of laws becomes even more pronounced as we see that the ultimate leader in Scripture is God the Father, and then His Son who fulfills the Father's will (John 5:30, 36). The Ten Commandments are not empty laws but a description of what's best for us as God's people, and we trust and believe this because of the person and leader to whom they point—Christ, the one who keeps the law perfectly and then lays down His life, so our faith can be in Him. As Christians, our primary devotion is not to justice as interpreted by modern culture but to our true Leader who establishes justice on a cosmic scale as Father, Son, and Holy Spirit. Only in the Father who creates, the Son who redeems, and the Holy Spirit who sanctifies, can we find justice with any authority worthy of our trust.

Church Council Meeting St. Paul's Ev. Lutheran Church September 21, 2020

Opening Devotion was led by President Larry Jung.

The minutes of the August 17, 2020 meeting were approved with a motion by Nate Bode and a second by Jon Mesmer.

Taylor reviewed the treasurers report and mentioned that the finances are still good thanks to the Paycheck Protection Program. The treasurers report was approved with a motion made by Nate Bode and a second by Paul Swanston

Board Minutes were discussed and Nate Bode reported that the Elders are continuing to go through call lists of members that haven't attended any services in quite some time. They have also been reviewing the call process and also planning for the 24 hour prayer vigil coming up on Oct 3rd. He reported that someone from the seminary will be visiting the church in regards to our upcoming calls.

Applying Biblical Principles

When you were very young, did you ever daydream about what you wanted to be when you grew up? Probably all of us did. Little girls though about becoming nurses, models, or flight attendants. Little boys thought about becoming policemen, firemen, soldiers, or truck drivers. Today, both boys and girls think about becoming astronauts, politicians, business leaders or even President of the United States.

One thing that probably none of us ever envisioned was to become a servant. Say what—a servant? That's how Christ described Himself in Luke 22:27 as He said,"...I am among you as one who serves." Jesus came not to be served, but to serve.

Even the Apostle Paul — whom we sometimes envision as a cross between John Wayne, Clint Eastwood and the Hulk — on several occasions called himself "a servant." As Chuck Swindoll put it,

This man, the one who certainly could have expected preferential treatment or demanded a high-and-mighty role of authority over others, referred to himself most often as a "servant" of God. Amazing. He was indeed an apostle, but he conducted himself, he carried himself, as a servant.

Regardless of what they do or how they do it, servants have one thing in common: They do the bidding of their masters. And that includes Christians who do the bidding of their Master, Jesus Christ. At least that's what we are supposed to do.

Juan Ortiz, a pastor in Argentina, described us this way:

We are all upside down. The lords sit in the pews. We treat Jesus as if He were our slave. We pray, "Lord" (but our attitude is just the opposite), "I'm leaving now. Please watch the house so that no one breaks in while I'm gone. And please keep me from an accident while I drive."

What do we expect Jesus to say? "Yes, ma'am" or "Yes, sir"?

Servants don't say, "Lord, do this and do that." Servants say, "Lord, what do You want me to do?" The satisfaction of the servant is to see the Lord satisfied. No wonder our churches don't work right. We have not begun to think about how to serve Jesus. Our praises are His dinner. The hymns are the water on His table. The offering is yet another part of His meal.

Can you say you have done everything that Lord told you to do? If so, we can have a graduation ceremony for you. We will give you a diploma that reads, "Unworthy Slave."

...One I was in a meeting where someone was introduced with great fanfare. The organ played and the spotlights came on as someone announced, "And now, the great servant of God."

If he was great, he was not a servant. And if he was a servant, he was not great. Servants are people who understand that they are worthy of nothing. They work eight hours and then come in and fix dinner for their Lord — and are refreshed and joyful when they see their Lord enjoying the meal.

May God help us to do with joy what servants in the kingdom do.


Being created carries a lot more truth than we may realize. Something that is created is:
